We are already booked December through March and continued phone calls. There is

a solar project being proposed in Inyokern, the District was not notified by Kern County Planning, but we have drafted a letter of response to ensure they comply with FAA regulations. Seymour reported that he was on the first flight out of Inyokern by the new Boutique Airline and everything was very smooth and easy. There are continuous itineraries being booked for the future. People have begun sending in their pledge money for community match for the grant. Seymour thanked Tim Jacobs and staff at Western Homes for making the home for airline staff turnkey. Also Springhill Suites gave very fair rates for startup staff stay.
